Terms and Conditions

1. Purpose of the 100 Club

The North Down Hockey Club 100 Club is a fundraising lottery operated for the benefit of the club and our sporting purposes..

After the payment of prizes and reasonable administration expenses, all proceeds will be applied solely towards the purposes of North Down Hockey Club.

2. Eligibility

1. Membership is open to persons aged 18 years or over.
2. Members must reside in the United Kingdom unless otherwise agreed by the Committee.
3. Committee members, employees and volunteers of the Club may participate
4. Membership is subject to acceptance by the committee

3. Registration and Compliance

1. The 100 Club will be operated in accordance with all applicable legislation governing lotteries in Northern Ireland, including the Betting, Gaming, Lotteries and Amusements (Northern Ireland) Order 1985 (as amended).
2. Where required by law, the Club will maintain registration with the relevant local authority for the operation of a society lottery.
3. Participation in the 100 Club constitutes acceptance of these Terms and Conditions.

4. Membership and Numbers

1. Membership shall cost £10 per month per number.
2. Members may purchase more than one number, subject to availability.
3. Numbers will be allocated on a first-come, first-served basis.
4. Membership is not transferable without the prior written approval of the Club
5. The Club reserves the right to reallocate unpaid numbers.

5. Payment

1. Payment should be made by standing order to the Club's bank account
2. Only members whose payments have been received by the agreed cut-off date will be entered into the next draw.
3. Failure to maintain payments may result in suspension or cancellation of membership.

6. Monthly Draws

1. Draws will normally take place on or around the 30th of each month.
2. All draws will be conducted fairly and randomly.
3. The draw may be undertaken manually or by an approved electronic random number generator.
4. In exceptional circumstances, the Club may alter the draw date.

7. Prizes

1. Prize values will be determined annually by the Committee
2. The Club reserves the right to vary the prize structure depending on membership levels and fundraising requirements.
3. The current prize structure is:
 - First Prize: £250
 - Second Prize: £150
 - Third Prize: £100
 - Christmas Bonus Draw from 2027 - £500 (December draw)
4. Prize winners will be notified within 14 days of the draw.

The prize structure is based on all 100 numbers being sold. If the numbers sold are less than the prize pot (£500) then the prize structure will be revised and based on a percentage of the current numbers sold, 25% 1st prize, 15% 2nd Prize, 10% 3rd Prize.

8. Payment of Prizes

1. Prizes will normally be paid within 30 days of the draw.
2. Payments will be made by bank transfer
3. The Club may require proof of identity before releasing prize money.
4. Unclaimed prizes remaining uncollected after 12 months will be treated as a donation back to the Club

9. Publication of Winners

1. The Club may publish winners' names and winning numbers through newsletters, websites, social media channels or other Club communications.
2. Members who wish to remain anonymous should notify the Club in writing.

10. Cancellation

1. Members may cancel their participation at any time by giving written notice.
2. Cancellation will take effect after the end of any prepaid period.
3. The Club reserves the right to terminate membership where:
 - Payments are not maintained;
 - False information has been provided;
 - The member breaches these Terms and Conditions;
 - Continuing membership would bring the Club into disrepute.

11. Data Protection

1. The Club will process personal information in accordance with the UK GDPR, the Data Protection Act 2018 and the Club's Privacy Notice.
2. Information collected will only be used for the administration of the 100 Club and related Club communications where consent has been provided.
3. Personal data will not be disclosed to third parties except where required by law.

12. Liability

1. The Club accepts no responsibility for lost, delayed or incorrectly processed payments.
2. The Club shall not be liable for any loss arising from events beyond its reasonable control.
3. The decision of the Committee in relation to all matters concerning the 100 Club shall be final.

13. Amendments

The Club reserves the right to amend these Terms and Conditions at any time to ensure compliance with legal, regulatory or operational requirements. Members will be notified of any significant changes.
